Associate members may work for state departments of health or other state agencies, federal governmental agencies, national non-governmental organizations, local education agencies, universities, and companies that support health and physical education programs in schools.</p> <p>Cannot vote on official Society business-may serve as Secretary, Treasurer, or Member-at-Large and have voting privileges on the Board of Directors.</p>	\$75
